## **Business Units**

*Student Transportation* is responsible for all elements associated with the planning and provision of student transportation services.

*Community Use of Schools* promotes and coordinates community access to school space, outside regular school hours.

*Child Care Services* is committed to building strong child care partnerships to support students, families and communities.

*Energy & Environmental Services* provides consultative leadership, expertise, and support in the areas of energy conservation and sustainable stewardship for the Boards.









## **Corporate Structure**

To ensure appropriate transparency for our separate legal entity, CLASS has two defined committees to provide oversight, direction and governance. These committees are comprised of Senior Officials from both Boards who in turn report back to their respective Boards of Trustees on CLASS items.

### **Board of Directors**

Consisting of Directors of Education and Senior Business Officials from both Boards; they are responsible for policy, fiscal accountability, high level oversight and strategic direction.

### **Operations Committee**

Oversight areas include procedures, budget, operational items and contracts. This committee consists of Senior Business Officials from both Boards, and the CLASS General Manager.

*Continuous Improvement* to ensure our organizational structure is effectively prepared to support Boards' needs.


*Organizational Excellence* to improve staff expertise to support continued shared service value for the Boards.

We service over 90 schools throughout Chatham-Kent and Sarnia-Lambton and our service area covers almost 5,500 square kilometers.

### Financial Perspective Initiatives

- Conducted routing efficiency studies and implemented bell time change in Petrolia to achieve cost avoidance.
- Performed system routing simulations to support Ministry of Education work on updated Provincial student transportation funding model.
- Continued leveraging of GPS data to drive routing efficiencies and to validate service quality & contract compliance.

### Stakeholder Value Initiatives

- Leveraged online training platform for the rollout of new CLASS driver training modules addressing pandemic safety protocols.
- Expanded e-form tools to include data collection for minor operational safety incidents such as mid-run student transfers.
- Addressed identified 3<sup>rd</sup> party contact centre start-up service challenges and gaps with market analysis and renegotiation work to ensure future stability.

### **Continuous Improvement Initiatives**

- Launched online School Site Traffic Management Plans (SSTMPs) tool to support school communities.
- Established working committee with key bus operator representatives focused on driver recruitment & retention data collection and initiatives.
- Formalized CLASS commitment to environmental stewardship in student transportation with Idling Policy.

### **Organizational Excellence Initiatives**

- Completed 3-year refresh training for drivers on Emergency Preparedness training (First Aid/CPR etc.).
- Launched <u>www.schoolbusjob</u> website platform to promote jobs in school busing and provide central inquiry platform.
- Ensure CLASS representation and participation in key committees: Ministry of Transportation School Bus Safety Task Force, OASBO Active Travel Sub-Committee.

### Financial Perspective Initiatives

- Leveraged re-opening periods to re-establish relationships with community groups, support grant use for non-profits and generate rental revenues to offset administrative overhead.
- Introduced *Interac* e-Transfer payment option for user groups to enhance payment efficiency for groups and reduce costs.
- Administered third-party tenant lease renewals to ensure the program is operating on a cost recovery basis.



### Stakeholder Value Initiatives

- Liaised with Public Health to coordinate school based COVID-19 vaccine clinics vaccinating students & community members.
- Liaised with Elections Ontario and local Municipal Returning Officers to coordinate school site usage as required for 2021-2022 polling stations.
- Supported a member Board with graphical design modernization of budget and school profile documents.

### **Continuous Improvement Initiatives**

- Developed 'outdoor sports complex rental information packages' to promote these venues and provide site specific photos/specs to potential rental groups.
- Invited to participate in 'Piktosquad' community to exchange graphic design expertise and make software update suggestions.
- Developed, implemented and maintained procedures, resources, and tools to support all stakeholders and ensure safe school rentals in evolving pandemic conditions.



#### **Organizational Excellence Initiatives**

- Assumed a lead role in maintaining Provincial 'Safe Return to School Rentals' resource document for Ontario school boards.
- Leveraged Community Use of School staff resources to aid and support other CLASS business units for initiatives related to the pandemic response and beyond.

- Supported Boards budget planning with lease / license revenue projections.

- Supported Child Care expansion in schools' initiatives with administration of license & grant applications and documentation.

- Liaison and administrative work to create effective procedures and documented agreement for partner use of community room.

### Financial Perspective Initiatives

- Enrolled Board new school construction projects into Enbridge 'Savings by Design' program to support energy efficient new school facilities and capitalize on incentives.
- Actively pursued over fifty incentive/rebate opportunities associated with capital projects & retrofit initiatives.



#### Stakeholder Value Initiatives

- Prepared and submitted Ministry of Environment mandated annual greenhouse gas and water / alternative fuel consumption report submissions for the Boards.
- Initiated research and data collection on recycling practices for all school sites to establish baseline to augment waste audit results.
- Consolidated utility consumption data for all school facilities into comparative results to assist Boards in directing future facility improvement focus.


### **Continuous Improvement Initiatives**

- Delivered 9 environmental and conservation focused online student engagement sessions with activities in collaboration with the Science Discovery Squad.

- Continued participation in the Provincial-led Power BI pilot group for the Utility Consumption Database.

- Created and launched CLASS-led joint environmental committee core team with multi-disciplinary representation from both Boards with focus on common environmental stewardship improvement opportunities.
- Enhanced business unit bench strength & credentials with completion of Canadian Institute for Energy Training (CIET) Certified Energy Manager designation.
